### FROM THE EDITOR

#### The Future of Paralegals in Uncertain Times

New jobless claims rose in the United States last week while the number of Americans out of work for more than a week hit the highest level in nearly a decade.

The Labor Department also reports new claims for unemployment benefits rose to 488,000 in the week ending November 24, 2001 and the number of continued claims, or jobless people still looking for work, jumped to 4 million in the week ending November 17, 2001, it was the highest level of continued claims since 1982.

While we hear news such as this and we experience first hand friends and family being laid off from their jobs, we need to keep in perspective the positive aspects of being a paralegal in these uncertain times.

While the Labor Department reports of unemployment, they also report that employment of paralegals are expected to grow by at least 36 percent through the year 2006. This means an estimated 77,000 new jobs by year 2005. Law firms and other employers with legal staff are increasingly hiring paralegals to lower the cost, and increase the availability and efficiency of legal services.

In Atlanta, where top firms offer over \$100,000 plus bonuses, it is deemed more economical to keep paralegals to perform many of the duties the attorneys have conventionally carried out. Further, the role of the paralegal is becoming more defined as paralegals are specializing in areas such as real estate, trademark and patent law, and now more than ever, bankruptcy and labor law are becoming increasing popular areas.

The bottom line is to remember what a valuable asset a paralegal is to any law firm or organization and that while unemployment is rising, the paralegal profession is still growing and paralegals remain in demand.

<u>Wills Clinic</u>. The Committee may consider another wills clinic as well such as we conducted in Douglasville in 2000 with Georgia Legal Services.

Animal Rights. My "pet" project in 2002 will be a foray into the rapidly expanding area of animal rights law. While not politicizing the issue and steering clear of protest marches and the like, I'll be researching ways in which Georgia paralegals could make substantive contributions towards protecting the legal rights of animals. Partnering with the Animal Legal Defense Fund might prove to be one of these ways.

Cobb Volunteer Probation Officer Program. Paralegals volunteering for this project would need to make a year's commitment and would function as probation officers for the Cobb County Court system. What an important way to live the NFPA pro bono slogan: "Paralegals Making a Difference"!

#### Update on Pro Bono

We have had a nice success this last year with the launch of our Committee newsletter *Pro Bono News*. Look for the newsletter to get even better in 2002. *Pro Bono News* comes out bi-monthly beginning in January and you may request for me to put you on our circulation list. ## HONEY, THEY SHRUNK THE STAFF!!

Take Heart - The Slowing Job Market Is Only Temporary! Since September 11th our ailing economy and already rising unemployment numbers soared to 5.4% on the shock of these events. Business froze while everyone absorbed the tragedy and tried to make sense of these cowardly acts. An already slowing job market slowed even further, but there is reason to be more optimistic than you think.

Human nature is resilient and so is our economy. You only have to look at the past economic downturns to see a light on the horizon. Our current slow down in hiring started in October of 2000 almost thirteen months ago. These contractions usually last 12 - 18 months. We expect to see the job market improving as we move through the first quarter of next year and see unemployment fall back to normal levels by the end of 2002.

But if you have been laid off or are looking don't get discouraged the economy is still creating jobs. A recent AMA survey showed while 58% of major corporations have had, or are planning, lay-offs, a third of these same companies were hiring

simultaneously. Despite the fact that the US is in an econ-omic slow-down, it is worth noting that more com-panies created jobs than eliminated them albeit a narrow margin than in the past. The US work-force is estimated to have grown this year by .04%!!

Our advise for those effected by layoffs or looking to make a career change is not to despair, but to work harder on their job search. The jobs are out there, it will take a little more effort to find the one you want. Companies and recruiters may not

come knocking as aggressively but hiring goes on. Find a career coach, a seasoned executive or recruiter to work with you, keep a positive attitude, employ all search strategies and never, never, ever give up.

## To sign or not to sign

I was recently faced with the question of whether a paralegal in Georgia is authorized to sign a Certificate of Service as "Paralegal for the Firm." I polled other members of GAP, and the overwhelming response was , "NO!"

The rules regarding this issue are different for actions in state court and federal court.

In Georgia state courts, a paralegal may sign a certificate of service, although the issue is not specifically addressed. O.C.G.A. § 9-11-5(b) states that "[p]roof of service may be made by certificate of an attorney or of his employee, by written admission, by affidavit, or by other proof satisfactory to the court" (emphasis added). Because of the vagueness of the term "employee," the statute would appear to include not only paralegals, but also legal secretaries and other staff members. This obviously could lead to a myriad of problems and must be better defined.

O.C.G.A. §§ 15-19-50 and 15-19-51 define the practice of law and the unauthorized practice of law, but neither address the issue of paralegals, or others, signing Certificates of Service. In Georgia federal courts, however, the rule is clear: no one other than an attorney (or a party if it is not represented by an attorney) may sign any document requiring a signature. Rule 11 of the Federal Rules of Civil Procedure states specifically:

(a) Signature. Every pleading, written motion, and other paper shall be signed by at least one attorney of record in the attorneys' individual name, or, if the party is not represented by an attorney, shall be signed by the party.


Fed. R. Civ. P. 11. Also, "Rule 11(a) requires that documents be signed by an attorney or (if there is no attorney) the party." Fed. R. Civ. P. 11(a).

I recently spoke with Steve Kaczkowski, Director of the Unauthorized Practice of Law ("UPL") Division of the State Bar of Georgia, about this issue. Mr. Kaczkowski has received several complaints about paralegals signing Certificates of Service. Complaints of this nature received in the UPL office are reviewed on a case-by-case basis for additional evidence of a paralegal signing documents (i.e.,

pleadings, or letters), giving legal advice, or not identifying the paralegal as such. While not condemning the practice, Mr. Kaczkowski does not condone it, and clearly prefers the abstention from the practice. Mr. Kaczkowski encourages paralegals with questions regarding this, or any other possible UPL issue, to contact his office at 404/527-8743.


Based on the statutory rules and policies cited above, Georgia state courts do not expressly prohibit a paralegal signing a Certificate of Service in his or her own name, as long as he or she is clearly identified as a paralegal, however the practice is discouraged. In Georgia federal courts, the practice is not allowed.
